MARKET SUMMARIES FOR JANUARY

Pacific Northwest (FO 124)

Producers delivered a total of 698.6 million pounds of milk to the market during January. Daily deliveries averaged 22.5 million pounds, up 1.1 percent from December. An estimated 607 producers delivered milk to the market during the month. Daily deliveries per producer averaged 37,128 pounds, up 1.1 percent from December.

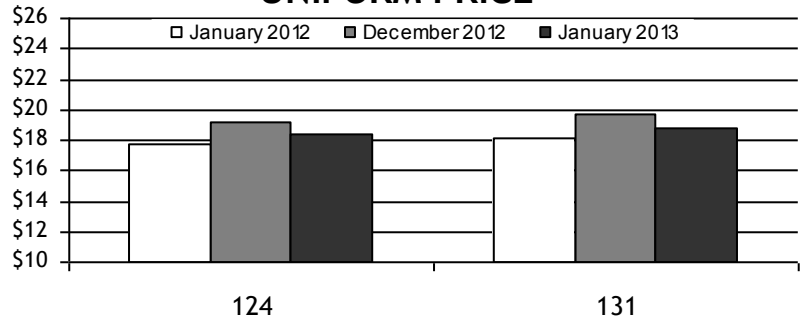
Class I producer milk during January totaled 190.3 million pounds, 27.2 percent of total producer receipts. Daily usage averaged 6.1 million pounds, up 6.3 percent from December. ▼

Arizona (FO 131)

Producers delivered a total of 398.2 million pounds of milk to the market during January. Daily deliveries averaged 12.8 million pounds, up 3.8 percent from December. An estimated 94 producers delivered milk to the market during the month. Daily deliveries per producer averaged 136,640 pounds, up 3.8 percent from December.

Class I producer milk during January totaled 118.4 million pounds, 29.7 percent of total producer receipts. Daily usage averaged 3.8 million pounds, up 2.7 percent from December. ▼

CURRENT COMMODITY PRICES

The AMS survey of cheddar cheese prices showed a net decrease in price received for 40-pound blocks and for 500-pound barrels. The survey of 40-pound blocks showed a net decrease of 9.60 cents between the January 12 and the February 16 surveys, to \$1.6582 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed a net decrease of 14.83 cents to \$1.5902 per pound.

The AMS butter price showed a net increase of 3.77 cents between the weeks ending January 12 and February 16 from \$1.5229 per pound to \$1.5606 per pound. The AMS nonfat dry milk showed a net increase of 0.95 cents since mid-January to \$1.5577 per pound. The average price for AMS whey showed a net decrease of 2.20 cents since mid-January to \$0.6342 per pound.

EXTENSION OF DAIRY FORWARD PRICING PROGRAM

The Dairy Forward Pricing Program, established under the 2008 Farm Bill, allowed forward price contracts between handlers and dairy farmers to be entered into through September 20, 2012. On January 2, 2013, legislation passed by Congress was signed by President Obama that extended the Dairy Forward Pricing Program by one year. Handlers may now enter into new forward price contracts with producers or cooperative associations of producers through September 30, 2013. All other provisions of the Dairy Forward Pricing Program remain the same.

USDA ISSUES FINAL DECISION ON AMENDMENTS TO MILK ORDERS

On February 7, 2013, the U.S. Department of Agriculture issued a final decision proposing permanent amendments to all Federal milk marketing orders. The decision proposes a permanent adoption of changes that are currently implemented on an interim basis. The amendments are based on the record of public hearing sessions held in 2007 in Strongsville, Ohio; Indianapolis, Indiana; and Pittsburgh, Pennsylvania.

The decision would permanently adopt changes to the manufacturing cost allowances and the butterfat yield factor used in Class III and Class IV product-price formulas applicable to all Federal milk marketing orders.

These amendments were adopted in an interim final rule in July 2008 and became effective in October 2008. The February 7 announcement also terminates the proceeding with regard to additional proposals that addressed the collection of manufacturing cost information, the use of an energy cost adjustor, and providing for a cost add-on feature to Class III and Class IV product-price formulas.

RESUMPTION OF ASSESSMENTS

On January 25, 2013, the market administrator issued a letter to all handlers advising them that the administrative assessment that was waived for the milk pooled during the months of September, October, November, and December 2012, will resume beginning with the milk pooled for the month of January 2013. The rate of 3.5 cents per hundredweight for the administrative assessment currently applicable to the Pacific Northwest and Arizona Federal Milk Orders remains in effect. 🐾
