MARKET SUMMARIES FOR JANUARY

Pacific Northwest (FO 124)

Producers delivered a total of 727.1 million pounds of milk to the market during January. Daily deliveries averaged 23.5 million pounds, up 4.2 percent from December. An estimated 587 producers delivered milk to the market during the month. Daily deliveries per producer averaged 39,959 pounds, up 4.2 percent from December.

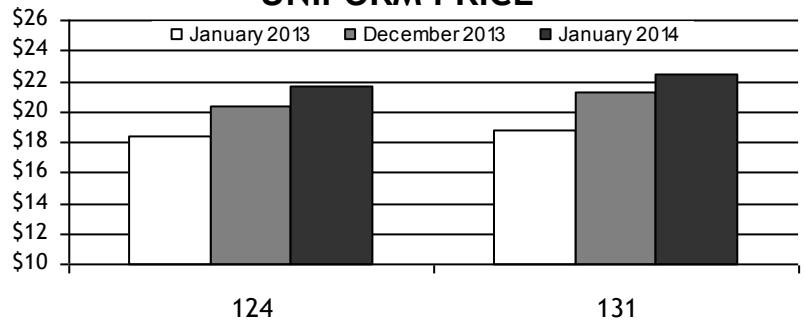
Class I producer milk during January totaled 182.6 million pounds, 25.1 percent of total producer receipts. Daily usage averaged 5.9 million pounds, up 2.2 percent from December. ▼

Arizona (FO 131)

Producers delivered a total of 415.9 million pounds of milk to the market during January. Daily deliveries averaged 13.4 million pounds, up 5.5 percent from December. An estimated 90 producers delivered milk to the market during the month. Daily deliveries per producer averaged 149,081 pounds, up 5.5 percent from December.

Class I producer milk during January totaled 120.4 million pounds, 29.0 percent of total producer receipts. Daily usage averaged 3.9 million pounds, up 1.3 percent from December. ▼

CURRENT COMMODITY PRICES

The AMS survey of cheddar cheese prices showed an increase in prices received for 40-pound blocks and for 500-pound barrels. The survey of 40-pound blocks showed an increase of 25.26 cents between the January 18 and the February 15 surveys, to \$2.3216 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed an increase of 28.21 cents to \$2.3244 per pound.

The AMS butter price showed an increase of 23.85 cents between the weeks ending January 18 and February 15 from \$1.6210 per pound to \$1.8595 per pound. The AMS nonfat dry milk showed an increase of 4.06 cents since mid-January to \$2.0766 per pound. The average price for AMS whey showed an increase of 3.27 cents since mid-January to \$0.6283 per pound.

RESUMPTION OF ASSESSMENTS

On January 24, 2014, the market administrator issued a letter to all handlers advising them that the administrative assessment that was waived for the milk pooled during the months of October, November, and December 2013, will resume beginning with the milk pooled for the month of January 2014.

The rate of 3.5 cents per hundredweight for the administrative assessment currently applicable to the Pacific Northwest and Arizona Federal Milk Orders remains in effect. 🐄

The U.S. Department of Agriculture is accepting applications for competitive grants to develop and accelerate conservation approaches and technologies on private agricultural and forest lands.

OPPORTUNITY FOR ALL ESTABLISHING A NEW MADE IN RURAL AMERICAN EXPORT AND INVESTMENT INITIATIVE

On February 7, 2014, the President directed his Administration, working through the White House Rural Council, to lead a new 'Made in Rural America' export and investment initiative. This initiative is charged with bringing together federal resources to help rural businesses and leaders take advantage of new investment opportunities and access new customers and markets abroad.

Specifically, the President has instructed his Rural Council - in coordination with the U.S. Department of Agriculture, the U.S. Department of Commerce, the Small Business Administration, the Export-Import Bank, the Office of the United States Trade Representative, and other agencies - to commit to connecting more rural businesses of all types to export information and assistance through a comprehensive strategy including the following specific commitments, to be provided over the next nine months:

- Host five "Made in Rural America" regional forums dedicated to promoting rural exports by providing rural leaders and businesses with information about federal and other resources available to help expand exports.
- Convene an "Investing in Rural America" conference later this year to connect major investors with rural business leaders, high-level government officials, economic development experts, and other partners.
- Host training sessions to equip local USDA Rural Development staff in all 50 states plus territories with the tools they need to counsel businesses on export opportunities and resources.
- Provide enhanced export counseling for rural businesses to connect with foreign buyers through the Department of Commerce's U.S. Export Assistance Center trade specialists in over 100 domestic locations and in collaboration with the U.S. Department of Agriculture's field staff.
- Coordinate across the Administration to promote rural-produced goods and services at trade events including trade missions, buyer programs, trade shows, and other promotion programs.
- Educate local leaders across the country on the importance of rural exports in partnership with NACo and through the Trade Promotion Coordinating Committee.
- Use the BusinessUSA online platform to better connect rural businesses with export and investment resources and coordinate support from across the federal government. 🐄
