MARKET SUMMARIES FOR JANUARY

Pacific Northwest (FO 124)

Producers delivered a total of 580.0 million pounds of milk to the market during January. Daily deliveries averaged 18.7 million pounds, down 20.0 percent from December. An estimated 467 producers delivered milk to the market during the month. Daily deliveries per producer averaged 40,067 pounds, down 1.0 percent from December.

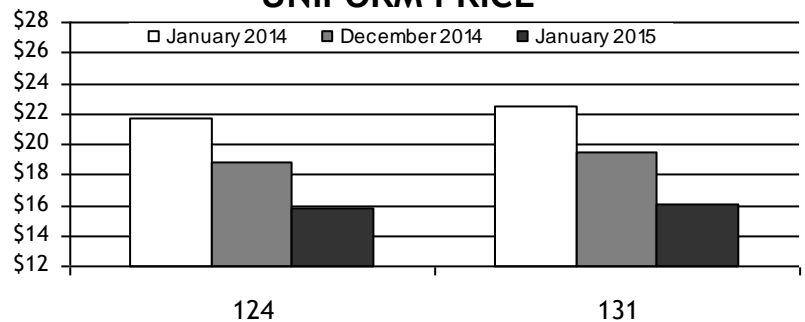
Class I producer milk during January totaled 175.7 million pounds, 30.3 percent of total producer receipts. Daily usage averaged 5.7 million pounds, down 0.3 percent from December. ▼

Arizona (FO 131)

Producers delivered a total of 410.8 million pounds of milk to the market during January. Daily deliveries averaged 13.3 million pounds, up 0.5 percent from December. An estimated 92 producers delivered milk to the market during the month. Daily deliveries per producer averaged 144,044 pounds, up 0.5 percent from December.

Class I producer milk during January totaled 110.8 million pounds, 27.0 percent of total producer receipts. Daily usage averaged 3.6 million pounds, up 0.8 percent from December. ▼

CURRENT COMMODITY PRICES

The AMS survey of cheddar cheese prices showed a decrease in prices received for 40-pound blocks and a net decrease for 500-pound barrels. The survey of 40-pound blocks showed a decrease of 5.56 cents between the January 17 and the February 14 surveys, to \$1.5258 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed a net decrease of 4.10 cents to \$1.5251 per pound.

The AMS butter price showed an increase of 14.66 cents between the weeks ending January 17 and February 14 from \$1.5510 per pound to \$1.6976 per pound. The AMS nonfat dry milk showed a net increase of 1.32 cents since mid-January to \$1.0230 per pound. The average price for AMS whey showed a decrease of 6.54 cents since mid-January to \$0.5270 per pound.

SUPER BOWL "SUPER KID"

The following is an excerpt of a USDA Blog post written by Whitney Rick, Director, Promotion, Research and Planning Division, Agricultural Marketing Service Dairy Programs

Minutes before the National Football League (NFL) teams of Super Bowl XLIX took the field, a middle school student from Orlando, Florida, had the honor of handing the game ball to an NFL official for the kickoff. But Bobby did much more than hand off that football. As this year's NFL Play 60 "Super Kid," the 12-year-old boy helped to inspire students across America to exercise daily and eat healthier foods.

He accomplished this feat through his relentless work with the Fuel Up to Play 60 (FUTP60) program, an outreach and education initiative founded by the National Dairy Council and the NFL, in collaboration with USDA. The program encourages youth in nearly 73,000 schools, representing almost 36 million students, to consume nutrient-rich foods—low-fat and fat-free dairy, fruit, vegetables and whole grains—and achieve 60 minutes of physical activity each day.

Bobby and thousands of other students entered the "Super Kid" contest. They pledged to be physically active daily for 60 minutes and submitted videos showing their personal commitment to outdoor exercise and a healthy diet. Bobby emerged as an articulate and passionate spokesperson for FUTP60, giving the program national exposure on Super Bowl Sunday.

The National Dairy Council is funded by assessments through the National Dairy Promotion and Research Program. The National Dairy Promotion and Research Board directs the program under the oversight of USDA's Agricultural Marketing Service. The program provides the funds for this initiative and many others by pooling industry assessments, setting common goals and making decisions about how to best develop new markets and strengthen current ones for fluid milk and dairy products.

Bobby's been a whirlwind of energy for the program, establishing a FUTP60 club in his elementary school and then in his middle school. 🐄

NATIONWIDE ORGANIC SURVEY UNDERWAY

In late-January, the U.S. Department of Agriculture kicked off the Organic Survey to gather detailed data on U.S. organic agriculture production. The survey is a complete inventory of all known organic producers that are certified, exempt from certification, and transitioning to certified organic production.

PROPOSAL FOR A FEDERAL MILK MARKETING ORDER FOR CALIFORNIA

On February 5, 2015, USDA received a formal hearing request from three California milk cooperatives to establish a Federal milk marketing order for the State of California. After conducting an internal analysis of the proposal, USDA will decide whether a hearing will be held.

USDA is also requesting additional proposals regarding a potential Federal milk order for California. Additional proposals must be received by April 10, 2015.
