### MARKET SUMMARIES FOR SEPTEMBER

#### Pacific Northwest (FO 124)

Producers delivered a total of 608.0 million pounds of milk to the market during September. Daily deliveries averaged 20.3 million pounds, up 6.8 percent from August. An estimated 454 producers delivered milk to the market during the month. Daily deliveries per producer averaged 44,642 pounds, up 4.4 percent from August.

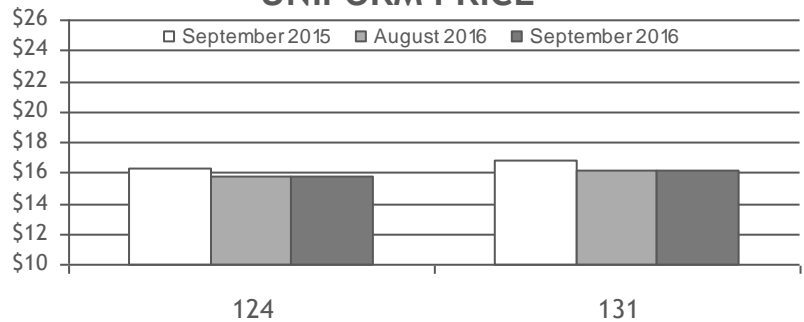
Class I producer milk during September totaled 167.6 million pounds, 27.6 percent of total producer receipts. Daily usage averaged 5.6 million pounds, up 6.9 percent from August. ▼

#### Arizona (FO 131)

Producers delivered a total of 348.1 million pounds of milk to the market during September. Daily deliveries averaged 11.6 million pounds, down 0.8 percent from August. An estimated 90 producers delivered milk to the market during the month. Daily deliveries per producer averaged 128,922 pounds, down 0.8 percent from August.

Class I producer milk during September totaled 108.0 million pounds, 31.0 percent of total producer receipts. Daily usage averaged 3.6 million pounds, down 0.6 percent from August. ▼

## CURRENT COMMODITY PRICES

The AMS survey of cheddar cheese prices showed a decrease in prices received for 40-pound blocks and a net decrease for 500-pound barrels. The survey of 40-pound blocks showed a decrease of 18.42 cents between the September 17 and the October 15 surveys, to \$1.5757 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed a net decrease of 17.87 cents to \$1.5440 per pound.

The AMS butter price showed a net decrease of 21.23 cents between the weeks ending September 17 and October 15 from \$2.0650 per pound to \$1.8527 per pound. The AMS nonfat dry milk showed a net increase of 2.42 cents since mid-September to \$0.9217 per pound. The average price for AMS whey showed a net increase of 1.81 cents since mid-September to \$0.3252 per pound.

## ERS ARTICLE

Processing and Marketing Blunt the Impact of Volatile Farm Prices on Retail Dairy Prices

*The following is an excerpt from an "Amber Waves" article.*

The average price received by dairy farmers for milk has varied between \$15.00 and \$25.70 per 100 pounds over the last five years.

Despite volatile farm-level milk prices, fluctuations in retail prices for whole milk and Cheddar cheese have been comparatively moderate.

Farm prices and retail prices track more closely for whole milk than for Cheddar cheese, reflecting the greater number of processing steps and marketing costs to supply cheese at retail stores.

ERS researchers analyzed dairy price movements to understand how quickly and how completely swings in farm-level prices reach consumers. Findings confirm that fluctuations in retail prices for whole milk and Cheddar cheese are less pronounced than swings in prices received by dairy farmers, and price changes experienced by farmers take time to reach consumers.
