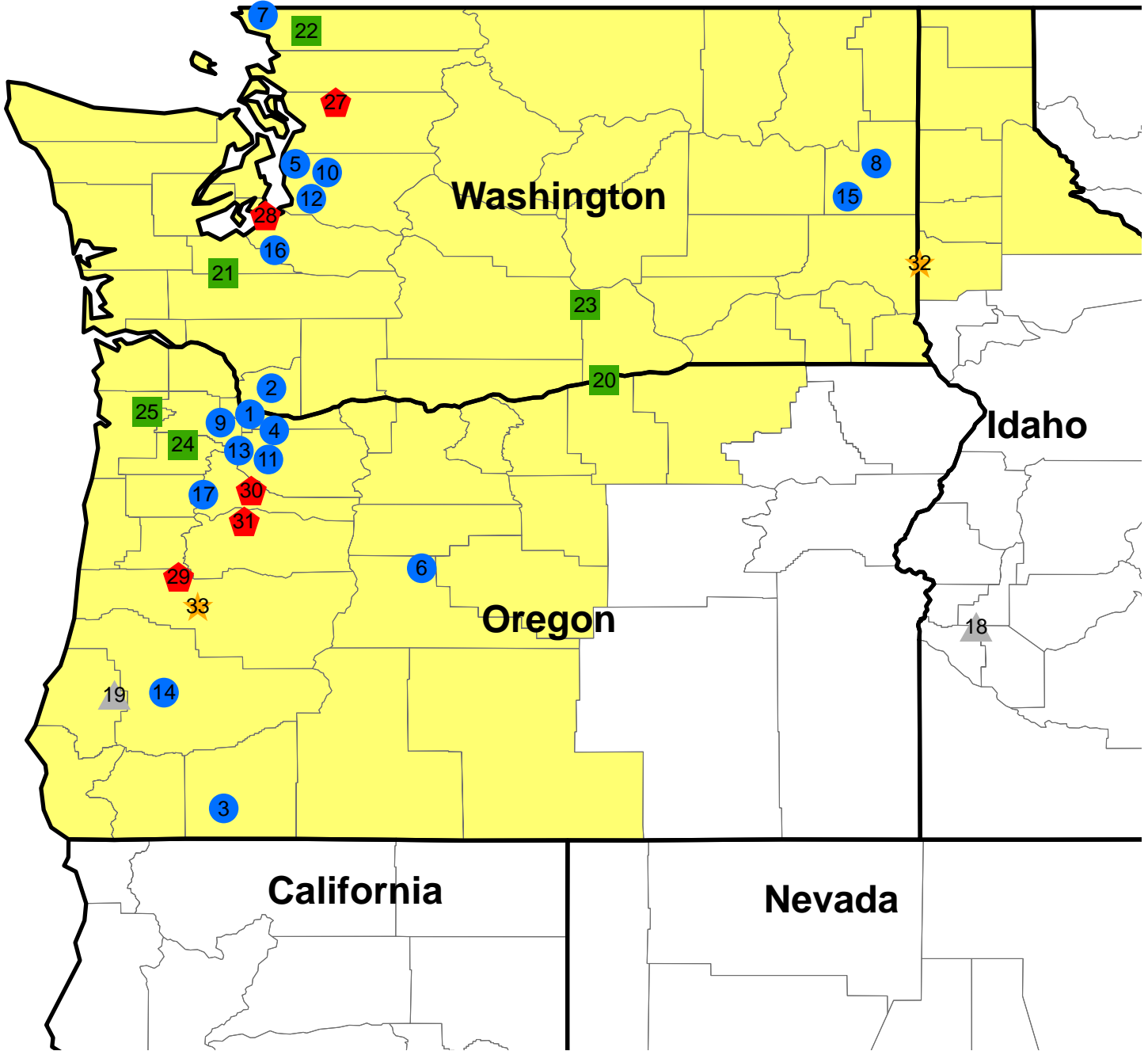


**MAP OF POOL, PRODUCER-HANDLER, AND EXEMPT PLANTS**
