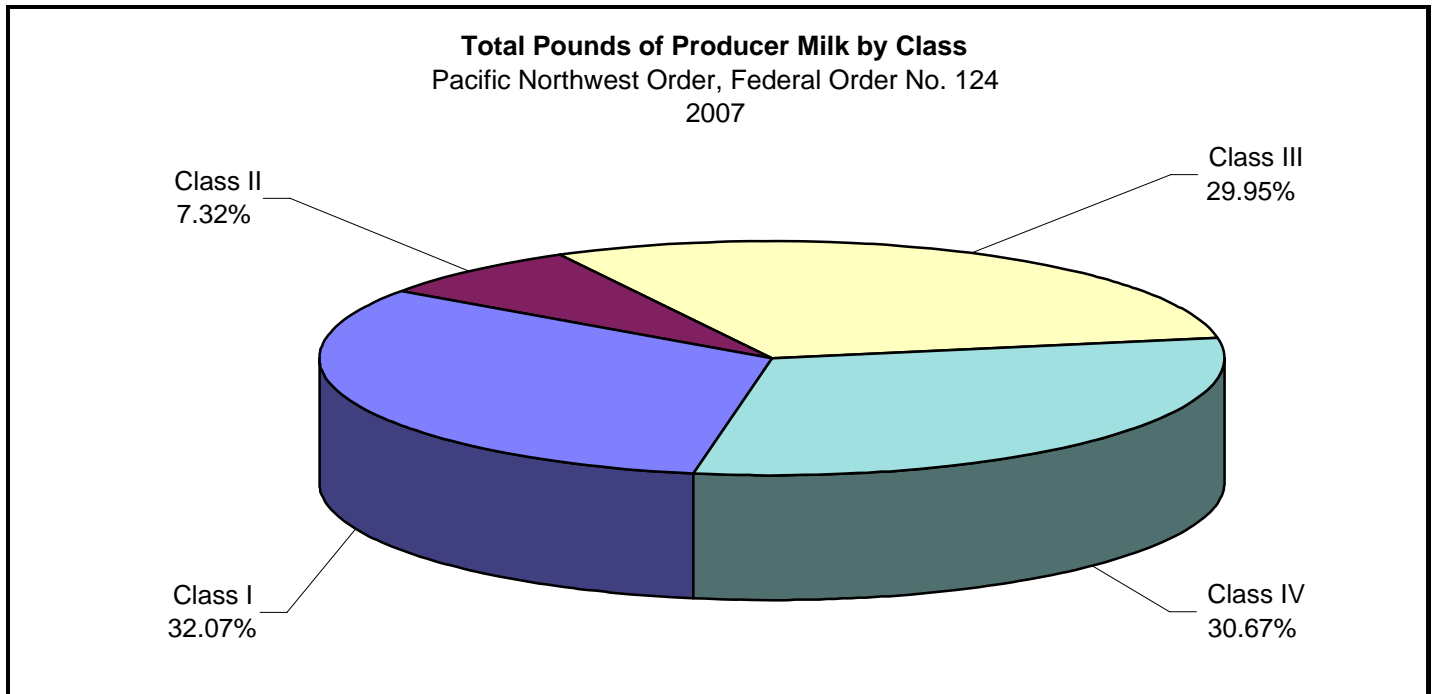

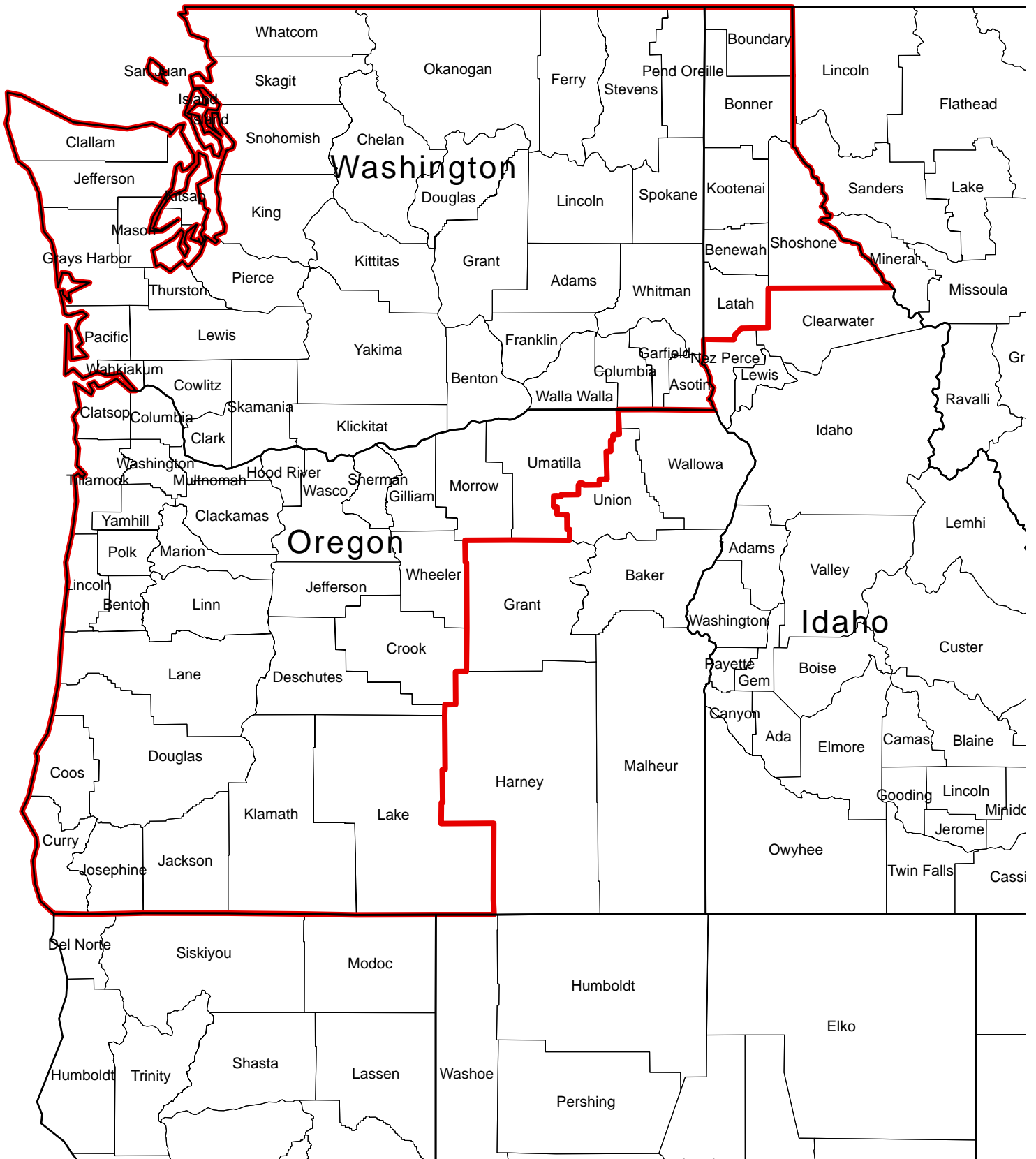

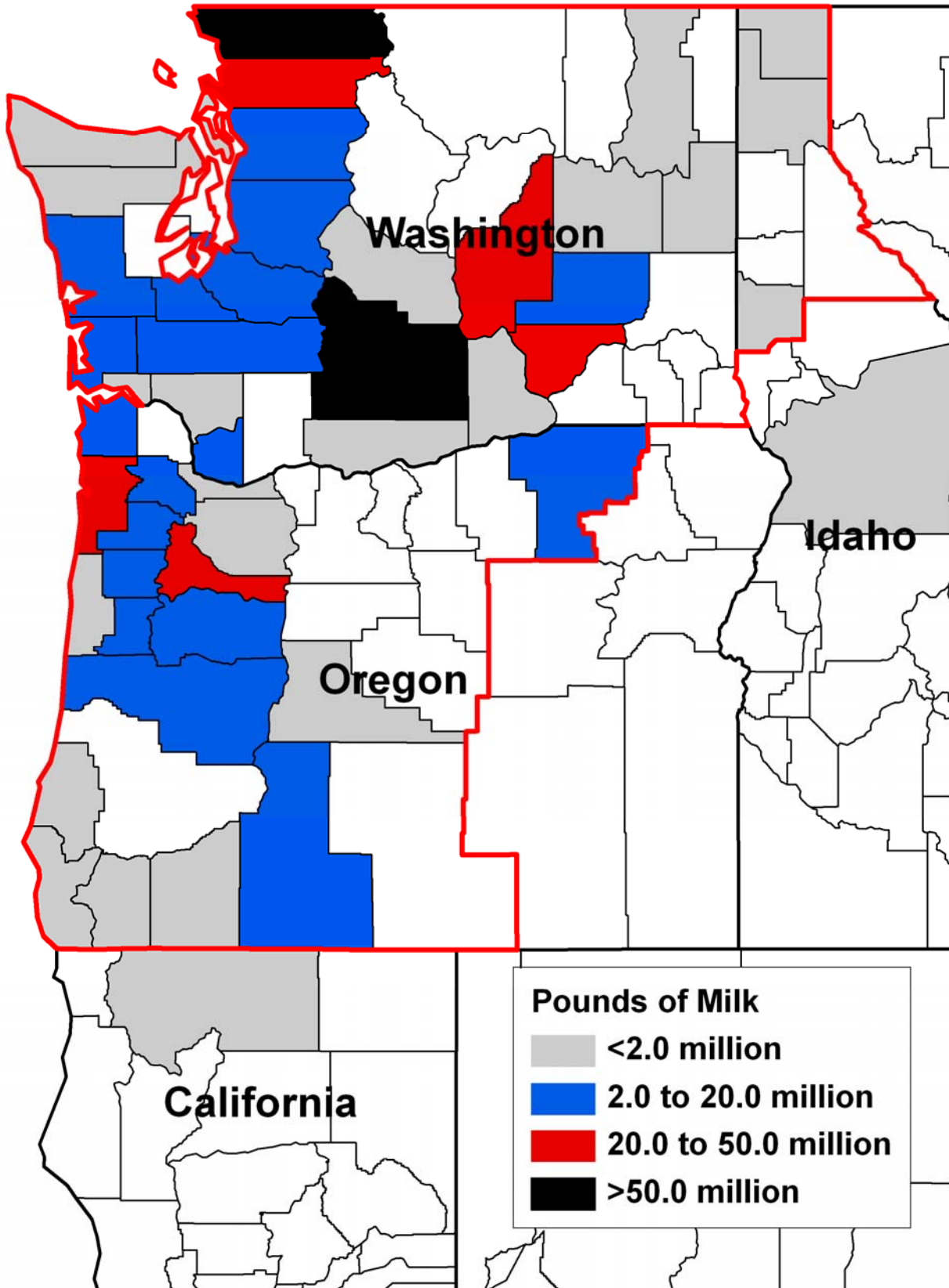
Map A

Pacific Northwest Order, Federal Order No. 124 – November 2007

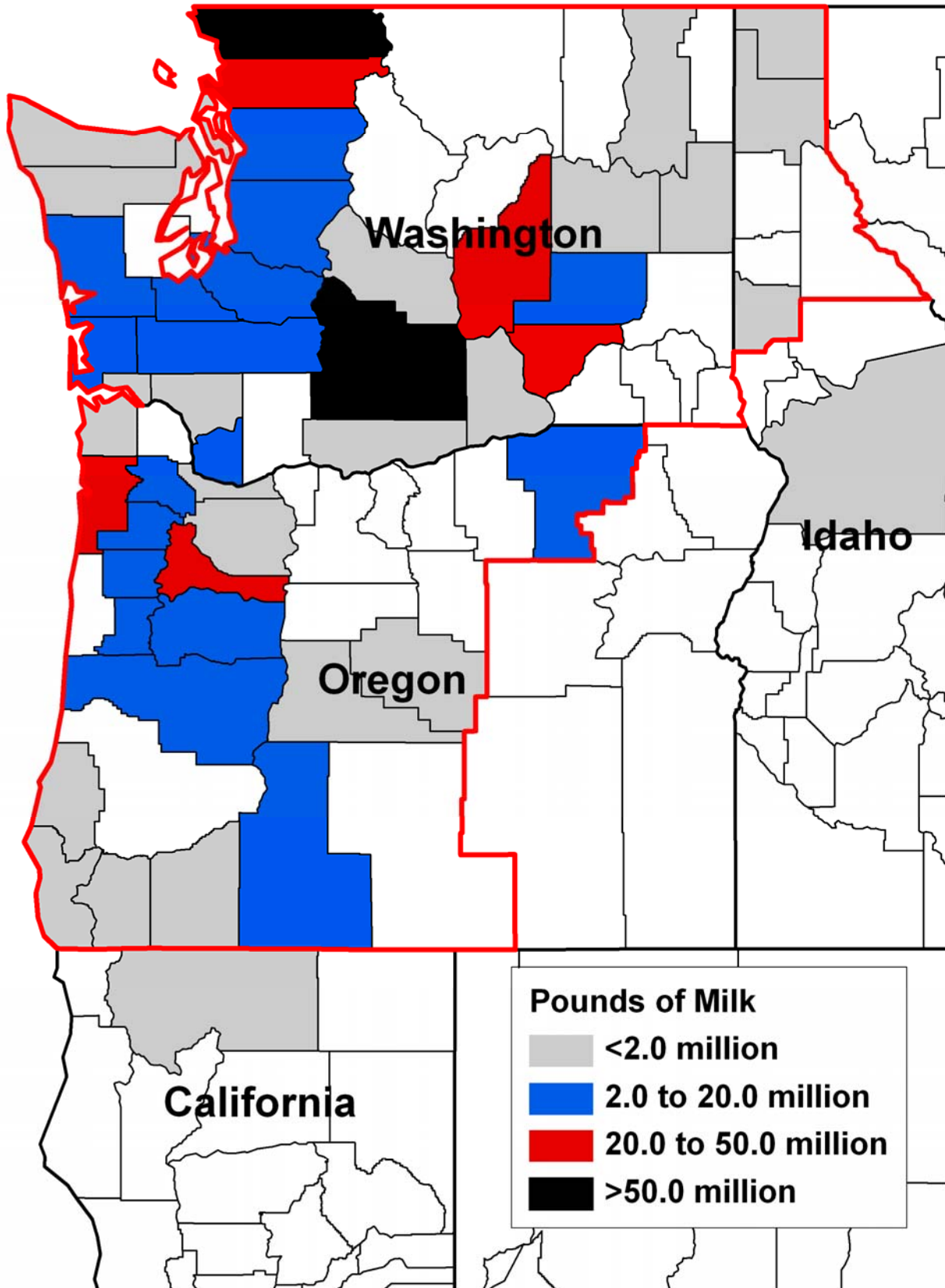
